We hereby propose to furnish the materials and perform the labor necessary for the completion of the following masonry work:

- For construction of trash enclosure, sign monument and building using split face CMU, Harvard Brik and cast stone sills and caps in colors and sizes as shown.
- For Dur-O-Wal every 16" on center vertically.
- For all reinforcment and control joints as shown.
- For BLOK-FLASH flashing at base of wall and over opening.
- For block, Harvard Brik and cast stone as per finish schedule sheet A2.
- NOTE: Four (4) mold charges included for the CMU and Harvard Brik.
- For natural colored mortar.
- · No caulking included.

All material is guaranteed to be as specified and the above work to be performed in accordance with the drawings and specifications for the above work and completed in a substantial workmanlike manner for the sum of as \$139,780.00 (One hundred thirty nine thousand seven hundred eighty and no/100's dollars) to be paid upon completion.

Any alteration or deviation from above specifications involving extra costs will be executed only upon written orders, and will become an extra charge over and above the estimate.

NO winterization is included in this price and shall be an extra charge.

NO permits, licensing or bonding included in proposal price.
